Legislative Update

GAMFT's Legislative Committee's success this year began with the groundwork laid from numerous members from previous years, and ended with the passage of HB 591 in the final hours of the 2021 legislative session.

Before this year, Georgia's 1,050 licensed MFTs were the only counseling discipline that were able to diagnose and treat clients experiencing mental health issues, but were not able to authorize emergency evaluations for those in

crisis. HB 591 has brought our profession's authority on this issue to parity with the over 8,500 licensed LPCs and over 8,200 social workers in the state. It is set to become law July 1, 2021.

It is with deep gratitude to our membership that we celebrate this moment. Many of you were a direct part of this success.

A model for success

The story of this success is at the heart of how our association should work, when at its best. We built on momentum, prepared the foundation, and asked for your active contributions.

Well before the 2021 session began, GAMFT members met with key legislators during the summer of 2019, as well as with representatives from the Behavioral Health Reform and Innovation Commission Report. We also met with lobbyists with the Department of Behavioral Health and Developmental Disabilities (DBHDD) to advocate for the 1013/2013 to be included in their agenda.

It was from this participation and advocacy that we ensured GAMFT's legislative priority for the 1013/2013 issue be included within the Behavioral Health Reform and Innovation Commission Report.



We continued to lay the foundation by also securing support from DBHDD, the [National Alliance on Mental Illness of Georgia](#), and the [Georgia Psychiatric Physicians Association](#).

During the session, our voice was loudly heard by state legislators – with over 300 emails being sent to them throughout the process. And the Committee worked to prepare a team to offer testimony that included Helen Morton, Steve Livingston, Dan Upshaw, Michele Smith, Courtney Geter, and Michael Chafin.

All of these efforts were supported by GAMFT’s new lobbyist, Elizabeth Appley, who helped us focus our efforts successfully. It is hard to imagine the successful passage of HB 591 without her hard work. Her expertise, attention, and follow-through proved critical at several points in the process where concerns and misunderstandings of the impact of our proposed change were raised by legislators.

We were also successful in applying for financial support from AAMFT toward our lobbying efforts. GAMFT hopes to be a future recipient of AAMFT's Practice Protection Fund (PPF) grants for legislative and advocacy issues relevant to the MFT profession. AAMFT created the Practice Protection Fund (PPF) to help defend the MFT profession from legislative and regulatory threats, as well as to help fund the advancement of the profession in every state. Preparing for our future

Georgia’s own Michael Chafin, while AAMFT’s president, worked hard to ensure the following paragraph is included in the AAMFT code of ethics:

Commitment to Service, Advocacy and Public Participation

Marriage and family therapists are defined by an enduring dedication to professional and ethical excellence, as well as the commitment to



service, advocacy, and public participation. The areas of service, advocacy, and public participation are recognized as responsibilities to the profession equal in importance to all other aspects. Marriage and family therapists embody these aspirations by participating in activities that contribute to a better community and society, including devoting a portion of their professional activity to services for which there is little or no financial return. Additionally, marriage and family therapists are concerned with developing laws and regulations pertaining to marriage and family therapy that serve the public interest, and with altering such laws and regulations that are not in the public interest. Marriage and family therapists also encourage public participation in the design and delivery of professional services and in the regulation of practitioners. Professional competence in these areas is essential to the character of the field, and to the well-being of clients and their communities.

In short, it is part of our ethical code to participate in activities that improve our communities and societies.

We are called to be concerned with “developing laws and regulations pertaining to marriage and family therapy that serve the public interest, and with altering such laws and regulations that are not in the public interest.”

The committee has already begun meeting with stakeholders to solicit input toward future legislative priorities.

With this momentum from our recent success driving us forward, we at GAMFT are excited for these next ventures, which are only made possible by the advocacy and efforts of our members. We encourage and welcome your input to our work. ■

Other Tracked Legislation

➔ **HB307: Georgia Telehealth Act; revise**

to revise the "Georgia Telehealth Act"; to revise definitions; to authorize health care providers to provide telemedicine services from home; to authorize patients to receive telemedicine services from their home, workplace, or school; to provide for related matters; to provide for an effective date; to repeal conflicting laws; and for other purposes.

Last Action: 5/4 Signed by Governor

➔ **HB 395: The Professional Counselors Licensure Compact Act; enact**

to amend Chapter 10A of Title 43 of the Official Code of Georgia Annotated, relating to professional counselors, social workers, and marriage and family therapists, so as to revise certain licensing provisions; to enter into an interstate compact known as the "Professional Counselors Licensure Compact"; to authorize the Georgia Composite Board of Professional Counselors, Social Workers, and Marriage and Family Therapists to administer the compact in this state; to authorize the board to conduct national background checks; to provide for conditions; to provide for eligibility; to provide for related matters; to provide for a short title; to repeal conflicting laws; and for other purposes.

Last Action: 5/10 Signed by Governor

➔ **HB 590: Mental health; grant program to establish assisted outpatient treatment programs**

to amend Title 37 of the O.C.G.A., relating to mental health, so as to provide for a grant program to establish assisted outpatient treatment programs for persons with mental illness who struggle to maintain engagement with essential mental health treatment; to provide for related matters; to provide for effective dates; to repeal conflicting laws; and for other purposes.

Last Action: 2/24 Introduced
